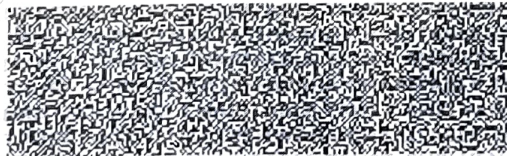

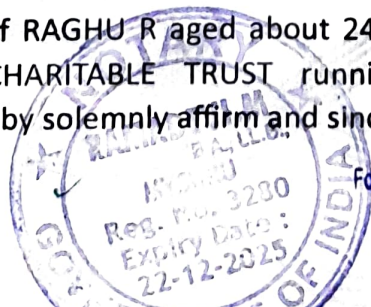


  
DIRECTOR OF CORRECTIONS
